Essay Requirements

Applicants are required to submit, as part of the application process, an essay written by them, that explains why they are deserving of this financial award. The applicant should include as much detail outlining financial need and their academic and career goals. The maximum length of the essay should be no greater than 1,000 words.

The 2019 submission deadline is March 31, 2019, for consideration of a scholarship for the 2019-2020 school year. Applicants will receive notification of the scholarship committee's decision for award approximately one month after the scholarship deadline. After all recipients have been selected and notified, scholarship monies will be distributed by the Community Foundation of the Eastern Shore and sent to the appropriate university or college in the recipient's name which may be applied to tuition, fees, room, board, books, or other educational supplies. Any scholarship recipients will be solely responsible for any applicable taxes with respect to any payments under this award.



Eligibility

The Allen Harim Legacy Scholarship is open to dependent children of employees or contract growers of Allen Harim who have completed at least one year of employment and who are in good standing with the company. Applicants must have a reputation of good character, maintain a minimum 3.0 GPA, and either be enrolled or enrolling in an accredited four-year college or university, an accredited two-year institution, or trade school on a full-time basis. Graduate students are also eligible provided that they meet all other eligibility requirements. Scholarships are awarded on a yearly basis. Applicants must reapply for consideration of the scholarship each year so long as they continue to meet the eligibility requirements.
